連接電源至總控盒

1. 將USB電源線一端接駁至USB電源插頭

- 2. 將USB電源插頭接駁至電源插座或拖板
- 3. 將USB電源線另一端接駁至總控盒背後的USB電源接口

注意:啟動過程中,總控盒的LED燈會出現不同燈號效果以顯示連接狀態,請參考 第14頁的PowerView[®]總控盒LED燈號顯示表以了解各種燈號的訊息。請勿中斷啟動 過程直至總控盒準備好連接到家居WiFi網絡或PowerView網絡。



連接總控盒至無線路由器

使用WiFi網絡連接:

等待總控盒LED燈轉為紫紅色亮燈,代表總控盒已準確好連接至WiFi網絡。於流動裝置中開啟PowerView®App並按螢幕顯示的步驟連接至WiFi網絡。成功連接WiFi網絡後,總控盒會安裝韌體並重新啟動。當總控盒轉為琥珀色閃燈,代表已可以加入PowerView網絡。

使用乙太網路線連接(可選):

用乙太網路線連接總控盒及路由器的LAN接口,總控盒會安裝韌體並重新啟動。 當總控盒轉為琥珀色閃燈,代表已可以加入PowerView網絡。

注意:如使用乙太網路線連接,請先接駁總控盒及路由器,完成後才接駁總控盒 電源。







將總控盒連接至現有的PowerView網絡

如你已為PowerView遙控器及窗飾建立了PowerView網絡,請將 總控盒連接至現有的PowerView網絡。首先開啟PowerView[®] App 並按指示進行設定,當總控盒的LED燈轉為藍色,代表總控盒已 成功連接至現有的PowerView網絡。

請按現場環境將無線伸延器安裝在所需位置。

注意:請勿將PowerView無線伸延器放於陽光直接暴曬的位置。





轉移總控盒資料(如有需要)

如你的PowerView網絡已加入總控盒1.0(左上),並需要將已儲存在的資料轉移至總控盒2.0,請開啟PowerView® App並按指示進行資料轉移。

測試無線伸延器訊號

按住PowerView[®]總控盒背後的P按鈕,無線伸延器會閃藍燈, 代表訊號接收正常。如無線伸延器沒有閃藍燈,請將無線伸延 器移至較接近總控盒的位置,或檢查無線伸延器是否已加入正 確的PowerView網絡。

總控盒背後的R按鈕,輕按一下可重新啟動總控盒(Restart),如 長按6秒會將儲存在總控盒內的資料刪除(Reset)。



PowerView[®] App已準備好,可以開始使用。

在一個PowerView®網絡內,使用多於一個總控盒(可選)

當第一個總控盒與PowerView[®]網絡完成配對後,會被識別為 主要總控盒,其他總控盒會自動設為輔助總控盒(網絡接入點)。 請按照PowerView[®] App的指示進行輔助總控盒的設定。

注意:當輔助總控盒的LED燈會顯示綠色亮燈,代表已加入現有的PowerView®網絡。

常見問題:總控盒未能與PowerView® App連接
